

CARNIVAL CRUISE LINE & CIRQUE DU SOLEIL GREAT BARRIER REEF CRUISE GIVEAWAY TERMS AND CONDITIONS

1. The Promoter and Prize Supplier is Carnival plc trading as Carnival Cruise Line ABN 23 107 998 443) of Level 5, 465 Victoria Avenue, Chatswood, NSW Australia 2067, phone (02) 8326 4000 ('**Promoter**').
2. Instructions, prizes and information on how to enter form part of these Terms and Conditions. By entering, entrants accept these Terms and Conditions.

Entry

3. The Promotion commences at 09:00 AM AEST Tuesday 16 September 2025 and ends at 11:59 PM AEST Sunday 12 October 2025 ('**Promotional Period**'). Entries must be received within the Promotional Period.
4. Entry is only open to Australian residents, excluding ACT residents, aged 18 year or over.
5. Employees (and their immediate families) of the following entities are ineligible to enter this Promotion:
 - a) the Promoter;
 - b) the Prize Supplier;
 - c) any Co-Operative Partner directly involved in the administration or execution of this Promotion;
 - d) agencies and contractors associated with this Promotion, including advertising, marketing, legal, and fulfilment partners; and
 - e) any entity or individual otherwise prohibited from entry under applicable State or Territory laws.

For the purposes of this clause, "*immediate family*" includes: spouse, ex-spouse, de facto spouse, child or step-child (whether natural or adopted), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

6. Incomplete or indecipherable entries will be deemed invalid.
7. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

How to Enter

 - b. be willing and able to travel on the cruise Prize dates specified.
10. Only one (1) entry per person will be permitted.
11. Entrants must be available to travel on the specified cruise date. If a winner is unable to travel on those dates for any reason, their entry will be deemed invalid and the prize may be awarded to a reserve winner, subject to any directions from a regulatory authority.
12. All eligible entries will be entered into the draw (the '**Entry**').

Prize

 - a. one (1) Carnival Cruise Line 6-Day Great Barrier Reef cruise for the winner and one (1) accompanying guests (total 2 people) in a twin share Balcony room onboard Carnival Encounter departing Brisbane on Saturday 06 December 2025 (the '**Prize**').
15. The Prize includes:
 - a. select onboard main meals and snacks (with the exception of those restaurants and meals which have an additional cover charge);
 - b. select onboard activities, evening entertainment and comedy shows (with the exception of those activities and facilities which have an additional cover charge) as well as kids clubs;

The Draw

The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.
20. The winner will be notified by email within two (2) business days of the draw and their name will be published online at <https://www.carnival.com.au/competition/cirquedusoleil-cruise-giveaway>.
21. The winner will have until Monday 20 October 2025 to accept the Prize by following the instructions in the email and provide the names and details of all passengers. If the winner does not claim or accept the Prize by the stated deadline, a redraw will take place at the same location at 11:00am AEST on Tuesday 21 October 2025. The redraw winner will be contacted as per clause 20 and must accept the prize no later than Tuesday 28 October 2025, subject to any directions from a regulatory authority.
