# CARNIVAL CRUISE LINE & MELBOURNE RENEGADES TASMANIA CRUISE GIVEAWAY TERMS AND CONDITIONS

- 1. The Promoter and prize supplier is Carnival plc trading as Carnival Cruise Line (ABN 23 107 998 443) of Level 5, 465 Victoria Avenue, Chatswood, NSW Australia 2067, phone (02) 8326 4000 ('**Promoter**').
- 2. Instructions, prizes and information on how to enter form part of these Terms and Conditions. By entering, entrants accept these Terms and Conditions.

## **Entry**

- 3. The Promotion commences at 09:00 AM AEST Tuesday 19 August 2025 and ends at 11:59 PM AEST Sunday 05 October 2025 ('**Promotional Period**'). Entries must be received within the Promotional Period
- 4. Entry is only open to Australian residents, excluding ACT residents, aged 18 year or over.
- 5. Employees of the Promoter and their immediate family and agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 6. Incomplete or indecipherable entries will be deemed invalid.
- 7. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
- 8. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- 9. Any costs associated with entering the Promotion, including data costs, are the entrant's responsibility.

#### How to Enter

- 10. To enter, during the Promotional Period individuals must:

Submission of the completed entry form constitutes one (1) valid entry into the draw.
  - b) Melbourne Renegades members may enter their valid membership number at the time of entry to receive four (4) additional entries into the draw.
- 11. a) Subject to b) below only one (1) base entry per person will be permitted.
  - b) Melbourne Renegades members who provide a valid membership number at the time of entry will automatically receive four (4) bonus entries, for a total of up to five (5) entries per person in that scenario.
- 12. All eligible entries will be entered into the draw (the 'Entry').

#### **Prize**

- 20. - 21. The winner will have until Friday 10 October 2025 to accept the Prize by following the instructions in the email and provide the names and details of all passengers. If the winner does not claim or accept the Prize by the stated deadline, a redraw will take place at the same location at 11:00am AEST on Tuesday 14 October 2025. The redraw winner will be contacted as per clause 20 and must accept the prize no later than Friday 17 October 2025, subject to any directions from a regulatory authority.
