

## CARNIVAL CRUISE LINE & MOONLIGHT CINEMA SOUTH PACIFIC CRUISE GIVEAWAY – SYDNEY (‘PROMOTION’) TERMS AND CONDITIONS

1. The Promoter and Prize Supplier is Carnival plc trading as Carnival Cruise Line (ABN 23 107 998 443) of Level 5, 465 Victoria Avenue, Chatswood, NSW Australia 2067, phone (02) 8326 4000 (‘Promoter’).
2. Instructions, prizes and information on how to enter form part of these Terms and Conditions. By entering, entrants accept these Terms and Conditions.

### Entry

3. The Promotion commences at 09:00 AM AEDT Thursday 08 January 2026 and ends at 11:59 PM AEDT Wednesday 04 February 2026 (‘Promotional Period’). Entries must be received within the Promotional Period.
4. Entry is only open to New South Wales and Victorian residents aged 18 years or over.
5. Employees (and their immediate families) of the following entities are ineligible to enter this Promotion:
  - a. the Promoter;
  - b. the Prize Supplier;
  - c. any Co-Operative Partner directly involved in the administration or execution of this Promotion;
  - d. agencies and contractors associated with this Promotion, including advertising, marketing, legal, and fulfilment partners; and
  - e. any entity or individual otherwise prohibited from entry under applicable State or Territory laws.

For the purposes of this clause, “immediate family” includes: spouse, ex-spouse, de facto spouse, child or step-child (whether natural or adopted), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

6. Existing members of the Carnival VIFP Club and individuals who have won a cruise prize from Carnival Cruise Line within the past 12 months (as of the time of the draw) are not eligible to enter.
7. Incomplete or indecipherable entries will be deemed invalid.
8. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and to disqualify any entrant who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved.
9. Any costs associated with entering the Promotion, including data costs, are the entrant’s responsibility.

### How to Enter

10. To enter, during the Promotional Period, individuals must:

11. Only one (1) Entry per person is permitted.
12. Entrants must be available to travel on the specified cruise date. If a winner is unable to travel on those dates for any reason, their entry will be deemed invalid and the prize may be awarded to a reserve winner, subject to any directions from a regulatory authority.
13. All eligible entries will be entered into the draw (the ‘Entry’).

### Prize

14. The total prize pool value is up to AU\$5,488.00 (incl. GST).
15. There is one (1) prize to be awarded. The winner will win:
  - a. one (1) Carnival Cruise Line 12-Day South Pacific cruise for the winner and up to one (1) accompanying guest (total two people) in a twin-share balcony room onboard *Carnival Adventure*, departing Sydney on 04 May 2026 (the ‘Prize’).
16. The Prize includes:
  - a. select onboard main meals and snacks (with the exception of those restaurants and meals which have an additional cover charge);
  - b. select onboard activities, evening entertainment and comedy shows (with the exception of those activities and facilities which have an additional cover charge) as well as kids clubs;
  - c. taxes, fees and port expenses.
17. Itineraries are not guaranteed and onboard offerings are subject to change.
18. The Prizes do not include travel to/from the cruise departure/arrival port, travel insurance, passport or visa costs, items of a personal nature, or any onboard incidentals or upgrades.

19. If any guest does not hold a valid passport, they may be denied boarding.
20. Redemption of the Prizes is subject to Carnival Cruise Line's booking terms and conditions. Prizes are not exchangeable, transferable, or redeemable for cash. Prizes must be taken on the dates specified. No compensation will be offered for inability to travel.
21. The Prize must be taken as is. Changes to the cabin type or number of guests are not permitted. Upgrades, guest additions or changes to the itinerary are not permitted (even if the winner offers to pay the difference).

### **The Draw**

22. This is a game of chance. Skill plays no part in determining the winner.
23. The draw will take place at Carnival plc trading as Carnival Cruise Line, Level 5, 465 Victoria Avenue, Chatswood, NSW 2067 at 11:00am AEDT on Friday 06 February 2026. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.
24. The winner will be notified by email within two (2) business days of the draw and their name will be published online at <https://www.carnival.com.au/competition/moonlight-cinema-sydney-cruise-giveaway> within 30 days of the date of the draw.
25. The winner will have until Friday 13 February 2026 to accept the Prizes by following the instructions in the email and provide the names and details of all passengers. If the winner does not claim or accept the Prize by the stated deadline, a redraw will take place at the same location at 11:00am AEDT on Monday 16 February 2026. The redraw winner will be contacted as per clause 26 and must accept the Prize no later than Monday 23 February 2026, subject to any directions from a regulatory authority.
26. Final passenger details must be confirmed with the Promoter by Friday 03 April 2026 to allow for cruise booking confirmation. If passenger details are not provided by this date, the Prize will be forfeited and no compensation will be provided.
27. Subject to the unclaimed prize draw clause, if for any reason the winner does not take/ redeem the Prize (or an element of the Prize) at or by the time stipulated by the Promoter, then the Prize (or that element of the Prize) will be forfeited.

### **General**

29. The Promoter's decision is final and no correspondence will be entered into.

If the Prize (or part of the Prize) is unavailable, the Promoter, at its discretion, reserves the right to substitute the Prize (or that part of the Prize) with a prize of substantially equal value and/or specification, subject to any written directions from a regulatory authority.
31. With the exception of any expenses specifically included in the Prizes, all
  - a. costs associated with transport to/from the departure/arrival port will be the responsibility of the winner and accompanying guests and will not be borne by the Promoter; and
  - b. pre and/or post accommodation, shore excursions or other onboard activities, spending money, additional meals, taxes, insurance, passports, visas, vaccinations, transfers, items of a personal nature, in-room charges and all other ancillary costs are not included.
32. The winner and their accompanying guests are responsible for ensuring they have the necessary and valid travel documentation including, passports, any requisite visas, insurance and vaccinations. The winner and their accompanying guests will be responsible for any expenses incurred in obtaining necessary travel documentation, including any fines or penalties incurred as a result of not having the requisite travel documentation.
33. Prizes, or any unused portion of a prize, are not transferable or exchangeable and cannot be taken as cash. If the winner is, for whatever reason, unable to travel within the nominated period, or does not take an element of the Prize within the time stipulated then that element of the Prize will be forfeited by the winner.
34.
