CARNIVAL CRUISE LINE & ROKT SOUTH PACIFIC CRUISE GIVEAWAY TERMS AND CONDITIONS

- 1. The Promoter and Prize Supplier is Carnival plc trading as Carnival Cruise Line (ABN 23 107 998 443) of Level 5, 465 Victoria Avenue, Chatswood, NSW Australia 2067, phone (02) 8326 4000 ('**Promoter**').
- 2. Instructions, prizes and information on how to enter form part of these Terms and Conditions. By entering, entrants accept these Terms and Conditions.

Entry

- 3. The Promotion commences at 09:00 AM AEDT Monday 03 November 2025 and ends at 11:59 PM AEDT Saturday 28 February 2026 ('Promotional Period'). Entries must be received within the Promotional Period.
- 4. Entry is only open to Australian residents aged 18 years or over, excluding residents of the Australian Capital Territory. South Australia, and the Northern Territory.
- 5. Employees (and their immediate families) of the following entities are ineligible to enter this Promotion:
 - a. the Promoter;
 - b. the Prize Supplier;
 - any Co-Operative Partner directly involved in the administration or execution of this Promotion;
