

CARNIVAL CRUISE LINE X SYDNEY THUNDER 2025/26 SEASON COMPETITION TERMS AND CONDITIONS

1. The Promoter and prize supplier is Carnival plc trading as Carnival Cruise Line (ABN 23 107 998 443) of Level 5, 465 Victoria Avenue, Chatswood, NSW Australia 2067, phone (02) 8326 4000 ('**Promoter**').
2. Information on how to enter and the Prize (defined below) form part of these Terms and Conditions. By entering the Promotion, entrants accept these Terms and Conditions.

Entry

3. The Promotion commences at 09:00 AM AEDT Monday 03 November 2025 and ends at 11:59 PM AEDT Sunday 15 February 2026 ('**Promotional Period**'). Entries must be received within the Promotional Period.
4. Entry is only open to New South Wales residents aged 18 year or over.
5. Employees (and their immediate families) of the following entities are ineligible to enter this Promotion:
 - a) the Promoter;
 - b) any co-operative partner directly involved in the administration or execution of this Promotion;
 - c) agencies and contractors associated with this Promotion, including advertising, marketing, legal, and fulfilment partners; and
 - d) any entity or individual otherwise prohibited from entry under applicable State or Territory laws.

For the purposes of this clause, "immediate family" includes: spouse, ex-spouse, de facto spouse, child or step-child (whether natural or adopted), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

6. Incomplete or indecipherable entries will be deemed invalid.
7. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
8. Any costs associated with entering the Promotion, including data costs, are the entrant's responsibility.

How to Enter

9. To enter, during the Promotional Period individuals must:

 - b) Complete the entry form, including their first name, last name, date of birth, email address and phone number; and
 - c) Submit the fully completed entry form ('**Entry**').
10. Only one (1) entry per person will be permitted.
11. Entrants must be available to travel on the specified cruise date or attend the event on the specified date. If a winner is unable to travel or attend the event on the dates for any reason, their entry will be deemed invalid and the prize may be awarded to a reserve winner, subject to any directions from a regulatory authority.
12. All eligible entries will be entered into the draw.

Prize

13. The total prize pool value is up to AU\$7,948.00 (incl. GST).
 - a) Cruise Giveaway - \$4,948 (incl. GST); and
 - b) Legends Lunch - \$3,000 (incl. GST).
14. Cruise Giveaway
 - a) There is one (1) prize to be awarded. The winner will win:
 - b) one (1) Carnival Cruise Line 9-Day Great Barrier Reef cruise for the winner and up to three (3) accompanying guests (total 4 people) in a quad share balcony room onboard Carnival Adventure departing Sydney on Saturday 16 May 2026.
 - c) The Prize includes:
 - ii. select onboard main meals and snacks (with the exception of those restaurants and meals which have an additional cover charge);
 - iii. select onboard activities, evening entertainment and comedy shows (with the exception of those activities and facilities which have an additional cover charge) as well as kids clubs;
 - iv. taxes, fees and port expenses.

15. Legends Lunch Giveaway

- a) There are twenty (20) prizes to be awarded (each valued at \$150 incl. GST). Each winner will receive one (1) **'Lunch Package'** comprising lunch (including select meals and beverages) onboard Carnival Adventure for the winner and one (1) accompanying guest (total 2 people) on Friday 20 March 2026 while the Carnival Adventure ship is alongside at Overseas Passenger Terminal, The Rocks. Venue, meals and beverage options will be at the Promoter's discretion (the **'Prize'**).

The Draw

16. This is a game of chance. Skill plays no part in determining the winner.
17. The draw will take place at Carnival plc trading as Carnival Cruise Line, Level 5, 465 Victoria Avenue, Chatswood, NSW 2067 at 11:00am AEDT on Tuesday 17 February 2026. The Promoter may draw up to thirty (30) additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn or if a prize is not claimed.
18. The draw will occur in the following order:
 - a) **The first valid entry drawn** will be deemed the winner of the Cruise Giveaway prize described in clause 14; and
 - b) **The next twenty (20) valid entries drawn**, in the order they are drawn, will each be deemed the winners of the Legends Lunch runner-up prizes described in clause 15.
19. The winners will be notified by email within two (2) business days of the draw and their names will be published online at <https://www.carnival.com.au/competition/sydneythunder-cruiseandlunch>.
20. The winners will have until 10:00am AEDT on Tuesday 24 February 2026 to accept the Prize by following the instructions in the email and provide the names and details of all guests. If the winner does not claim or accept the Prize by the stated deadline, a redraw will take place at the same location at 11:00am AEDT on Thursday 26 February 2026. The redraw winner/s will be contacted as per clause 18 and must accept the prize no later than 12:00pm AEDT Thursday 05 March 2026, subject to any directions from a regulatory authority.
21. Final guest details must be confirmed with the Promoter by 5:00pm AEDT Monday 16 March 2026 to allow for security clearance. If guest details are not provided by this date, the Prize will be forfeited and no compensation will be provided.
22. Subject to the unclaimed prize draw clause, if for any reason the winner does not take/ redeem the Prize (or an element of a prize) at or by the time stipulated by the Promoter, then the Prize (or that element of the Prize) will be forfeited.

General

Except for any liability that cannot by law be excluded, the Promoter (including its respective officers, employees and agents) is not responsible for, and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the Promotion including but not limited to: a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); b) any theft, unauthorised access or third party interference; c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; d) any variation in prize value to that stated in these Terms and Conditions; e) if the Prize is delayed, postponed or cancelled for any reason beyond the reasonable control of the Promoter; f) any tax liability incurred by a winner or entrant; or g) use of and/or taking of the Prize.
